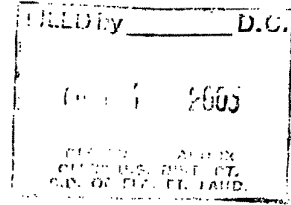

The Court notes that by prior Order (DE 18) the Court appointed a Receiver over the entities named in the above-styled




